Mode of Action

Skeeter utilizes a proprietary formulation containing millions of specialized juvenile nematodes plus our AMPx® processed surface treatment.

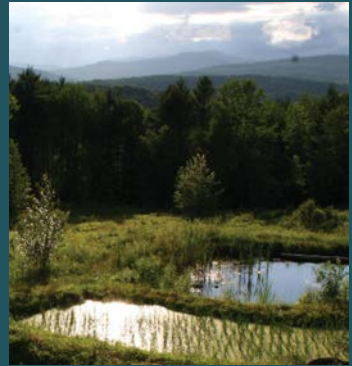
Once inside the larvae/pupae, the nematodes instantly release a symbiotic bacteria into the bloodstream. Once inside the blood, septicemia initiates and kills their insect hosts, this process happens within 48 hours after infection. The nematodes will reproduce as long as there is larvae/pupae and then they die off.

The surface treatment will spread evenly across the water where it will kill eggs, larvae, pupae, and suppress adults. The young adults leaving through the surface get coated, which induces neurological damage, inhibits their ability to sense CO2, and they die.
